Rolling Girl. Rolling Girl is the second single album by American recording artist Janelle Monae, released on the Virginia label Bad Boy Entertainment on April 21, 2015. The album is her first to be released through a major record label since the release of The ArchAndroid in 2011. It was preceded by the lead single, "Q.U.E.E.N.", which was released in December 2014. Rolling Girl had also been announced to be Monae's debut in the United Kingdom. It was initially slated for a fall 2015 release, but was delayed until April 21, 2015. Id. at 4-5. The court, relying on Virginia's multiple-victim statute, concluded that the defendant could have caused multiple, serious bodily injuries in the course of a single battery. Id. at 6. In Shaw, the defendant struck the victim on the head with a claw hammer, causing the victim to fall backward and hit his head, sustaining a blunt trauma to the head. Shaw, 966 S.W.2d at 7. The court found that the defendant intentionally inflicted serious bodily injury

upon the victim because he knew or should have known that his actions would cause a blunt trauma to the victim's head. *Id.* At least two years before *Malone* and *Shoemaker*, the Supreme Court of Virginia in *White* concluded that the "single purpose" requirement of the Code section was violated by a defendant who beat a victim to a pulp with a baseball bat, causing the victim to lose consciousness and suffer a broken nose and two broken ribs. *White*, 637 S.E.2d at 916. The defendant struck the victim in the head with the bat at least ten times, the beating causing him to lose consciousness at least three times. *Id.* at 915. The defendant was convicted of three counts of "malicious wounding," which was a lesser included offense of aggravated malicious wounding. *Id.* at 914. The court found that the
